The Animal Control facility is located in Whitecliff Park. The Animal Control Officer is the only staffer, working from 8 a.m. to 4:30 p.m. Monday through Friday. However, since his/her office is at City Hall, he/she is not usually at the shelter. Volunteers handle the evening shift seven days a week, the morning shift on Saturday and Sunday, and are also needed to help the Animal Control Officer on the morning shift Monday through Friday. Shifts are variable, depending on the number of animals that are being sheltered.

Volunteers are expected to commit to one (or more) shifts each week but are welcome to drop in at any other time to offer extra attention to special needs animals or provide exercise or playtime opportunities.
